These additional transfer charges are incurred due to the new venue in Cairo, The Egypt International Exhibition Centre, not having any customs bonded area, and as such we need to transfer from the current Customs Bonded area to the new venue.

Additional deliveries to multiple stand will be charged at \$ 100.00 per delivery / collection

Heavy Lift Surcharge Any cargo exceeding 500 x 250 x 250Cms or over 300kgs will be liable for 35% heavy lift surcharge

Bank Guarantee

Our charges to issue the guarantee will be charged at 6% of the CIF invoice value accepted by Customs authorities for 1 month Minimum charge USD 260.00. To renew the guarantee after 1 month our charges will be 3% per extra month with a minimum charge of USD 450.00 / LG

Any shipments to be re-exported will be held in the customs bonded warehouse after show till dispatch and storage will be charged accordingly this is also applicable for early arrival to the venue.

Please note that official receipts such as port/terminal charges are very likely to be incurred, per below they are excluded from these costs, please contact Ms. Claire Grimes once customs clearance is complete for update on official receipt charges.

Excluded:

1. Duties and Taxes + 10% outlay fee (unless arranging bank guarantee)
2. Third Party Charges
3. Port Demurrage / handling charges
4. Terminal handling charges / NVOCC
5. Waiting time for Containers
6. Insurance
7. Hire of equipment
8. CICC authority fees
9. Arrival Charges and/or any official receipts

10. Over time working Saturday 50% Sunday/Bank holiday 100%
11. Airfreight shipments are based on actual or volume, whichever the higher
12. All rates are charged per exhibitor and/or per shipment
13. Airport and port storage fees
14. Watchman fees
15. Unpacking and re-packing – this is the responsibility of the exhibitor and Agility Fairs & events take nil responsibility of goods left unpacked on their stand
16. **14% sales tax to be added on all incoming and outgoing charges**
