Please note: Goods arriving at Milano fairground under Customs Bond (TRANSIT) can be imported on temporary base only. Permanent entry is allowed after show closing only but for invoices over € 1.000,00 goods can be imported only if sold to an Italian/EU buyer with Italian VAT/EORI nr, otherwise permanent importation cannot be authorized.

GUARANTEE ON TEMPORARY IMPORTATION

For all goods arriving at Fiera Milano on temporary import basis, without Ata Carnet, a Guarantee on Customs duties & Vat (30% on CIF value of goods) must be provided. We kindly ask you to keep in touch with us to get all information about advanced payment to be done before delivering the goods to Fiera Milano.

In case of authorization of our Customs Broker, we can offer Bond Fee for the Temporary Import:

All these exhibition goods must be re-exported within 1 month from arrival date or must be permanently imported. Otherwise Customs duty/VAT and customs fine will be charged. VAT and duties will also be charged in case our re-export form (Transit Document) is not duly discharged at the Customs point of destination or at EU border/transit point.

DUTIES/VAT

Will be applied on all consumable / not re-exported items: on permanent entries to be billed as per customs receipt + 1% (Min. charge € 55,00).

*All services to be provided after 7:00 p.m. must be booked by fax or email before 3:00 p.m. on the same day.
For more than 15 min. delay the service will be cancelled and 1 hour debited.*

The storage service can be provided only for exhibits and it is strictly related to the build up and break down periods. Long-term warehousing can be provided only upon specific agreement.

If for our convenience a higher capacity forklift/crane is used to perform a service instead of the necessary one the tariff applied will remain unchanged as by original request.

For temporary import or re-export it's necessary to have a cash deposit or a bank guarantee equal to the amount of duties to be paid.

The empty storage service is only intended for empty packing materials. Agility F& E UK will not be responsible for the damage or loss of any material and/or goods left inside.

All services must be paid before the end of the exhibition by credit card, cheque or cash unless otherwise you have credit with Agility F& E UK . The invoice for the services will be sent to the email address used for the confirmation of booking.

Above rates do not apply to shipments of live animals, dangerous goods, perishable, valuables or any other kind of special cargo.

In case of cancellation of a pre-booked forklift service with a prealert of less than 5 hours, 1 hour service will be charged. The above tariffs apply only during official set up and dismantle dates; for any service requested outside these official periods a minimum of two hours will be charged.

All third party costs such as terminal handling charges, bill of lading fees, as well as demurrage, detention, stuffing or inspection charges, issuing of various certificates (CITES, Phitosanitary, Sanitary, Fumigation) will be billed as per outlay plus a disbursement fee of 1% on advanced fund (minimum charge EUR 125,00)

Further services not included in the present Handling and Logistic Tariff will have to be agreed in advance.
