## AIR FREIGHT

### Basic Handling Charge

For individual pieces not exceeding either 2000 kg or 200x100x200 cm in dimension.  
(1cbm=333kg based on actual or volumetric weight, whichever is greater)

**From free arrival Madrid Airport up to Agility Madrid Depot:** **0,35.-€/kg**  
Based on actual or volumetric weight, whichever is greater.  
Minimum Charges: **175.-€/shipment / exhibitor**

**From Agility Madrid Depot up to delivered into stand:** **0,75.-€ / kg**  
Based on actual or volumetric weight, whichever is greater.  
Minimum Charges: **200.-€ / shipment or exhibitor.**

**Not included** in the a.m. charges possible storage fees at the airport and handover charges to the airline (cession) if any per outlay + 5% disbursement fees.

## SEA FREIGHT

### Basic Handling Charge - LCL

For individual pieces not exceeding either 2000 kg or 200x100x200 cm in dimension.  
(1cbm=333kg-based on actual or volumetric weight, whichever is greater)

**From free arrival to Valencia Port up to Agility Madrid Depot:** **0,55.-€/kg**  
Based on actual or volumetric weight, whichever is greater.  
Minimum Charges: **225.-€ / Shipment or exhibitor**

**From Agility Madrid Depot up to delivered into stand:** **0,75.-€ / kg**  
Based on actual or volumetric weight, whichever is greater.  
Minimum Charges: **225.-€ / shipment or exhibitor.**

### Basic Handling Charge - FCL

For individual pieces not exceeding either 2000 kg or 200x100x200 cm in dimension.

From free on truck from Valencia port to Agility Madrid depot / IFEMA: **1150.-€ / container**

From Agility Madrid Depot up to delivered into stand: **20' DC 900.-€/container**

**40' DC 1200.-€/container**

**Not included** terminal handling at arrival / charges of local co-loader agency.  
We will charge the arrival charges until free on truck at Valencia seaport terminal per outlay + 5% disbursement fees. Contact us for HC/OT/FR.

## ROAD FREIGHT

For individual pieces not exceeding either 2000 kg or 200x100x200 cm in dimension.  
(1 cbm = 333 kg based on actual or volumetric weight, whichever is greater)

From Agility Madrid Depot up to delivered into stand: **65.-€ per CBM (min. 3 cbm)**

From arrival directly at Madrid exhibition center to delivery into stand: **12.-€ per CBM (min. 3 cbm)**

Van / less than 7.5 T	15 cbm

## COURIER SHIPMENTS

**Courier companies cannot do the customs clearance of shipments for events or exhibitions** as they need an importer with a Spanish tax ID.

Please avoid sending cargo with them. In case you send cargo through courier companies get in touch with us in advance.

We highly recommend sending your courier shipments to our warehouse address under **CFR Agility Madrid warehouse conditions**. This way you ensure your items arrive safely and on time. In that case, Agility will arrange customs clearance; therefore, we need a complete set of documents as mentioned on page number 7 of shipping instructions.

If Agility's assistance is needed, the following charges will apply:

Shipments above 50 kg will be treated as Air freight cargo
