For your guidance, we would like to give you shipping and documentary requirements for temporary importation of exhibits into the USA. It is important that all Shipping instructions are strictly adhered to in order to ensure quick and smooth clearance of consignments.

### Sea freight



Deadline for collecting of goods at your UK warehouse/office address:

**LCL - 6<sup>TH</sup> December 2019**

**FCL – 6<sup>th</sup> December 2019 \*\* FCL sea freight shipments we will load at the clients premises and take straight to the port**

Deadline for receiving of goods at our UK depot:  
**2<sup>nd</sup> December 2019**

### Airfreight



Deadline for collecting of goods at your UK warehouse/office address:

**10<sup>th</sup> February 2020**

Deadline for receiving of goods at our UK depot:  
**13<sup>th</sup> February 2020**

### Packing



All solid wood packaging materials/pallets must be treated and stamped in accordance to the ISPM15 regulation. Avoid sending goods in bubble wrap or flimsy cartons as this is not sufficient packing to protect them. We recommend the sturdiest packing you can provide. If necessary, invest in a sturdy, re-usable exhibition-packing crate

Heavy cases should indicate centre of gravity point

Pallets dispatched by airfreight must declare number of cartons per pallet.

Goods for temporary import and permanent import should be packed separately.

All packages should be clearly marked with:

- 5 sets of Commercial Invoice
- 5 sets of Packing list unless incorporated into invoice
- USA Customs Power of Attorney
- This form is necessary for Agility Fairs & Events or our agents to file any type of USA Customs Import or Export entry
- Non-Residential Corp. Certificate

## Security

Consignments arriving into the USA are subject to enforced security scrutiny via US Customs. Arrival deadlines and therefore departure dates have been set to allow for most eventualities. Airfreight and LCL cargo can be delivered to the appointed Drayage company's advance warehouse as soon as released by US Customs and most Drayage companies offer 30 days free storage prior to target date but full container loads (FCL) will incur port rent and container demurrage almost without exception. Any consignment selected by US authorities will incur transport and examination costs which must be passed back to the exporter.

**Shipper must review all available documentation and determine that none of the cargo being offered in this consignment or consolidation has originated in, transferred from, or transited through any point in Egypt, Somalia, Syria or Yemen."**
