3.1 Inbound

- Unloading, intermediate storage (incl. 3 days) and delivery to the stand € 45,00 / per 100,0 kgs (Min. 300,0 kg)
- Unloading and direct delivery to stand per 3to. Forklift € 17,50 / per 100,0 kgs (Min. € 125,00)

Chargeable weight / conversion rate: 1 cbm = 333 kg

3.2 Outbound

- Duties and taxes for permanent importation + 15% disbursement fee per outlay (Min. € 25,00)
- Import Bond fee 1,5% of CIF value (Min. € 125,00)
- Customs Transit Security fee 0,75% from CIF Value € 35,00 (min.)
- Demurrage / Detention per outlay (+ 15%)
- Port & Airport handling charges depends on NVOCC and country of origin (LCL + FCL // import + export) per outlay (+15%)
- AWB fee + x-ray scanning per outlay
- Consignment Processing Fee 12,5% of total amount Minimum € 65,00
- All other charges as per outlay

 - Saturday - +50%
 - Sunday / bank holiday - +100%
 - Late arrival - +30%
