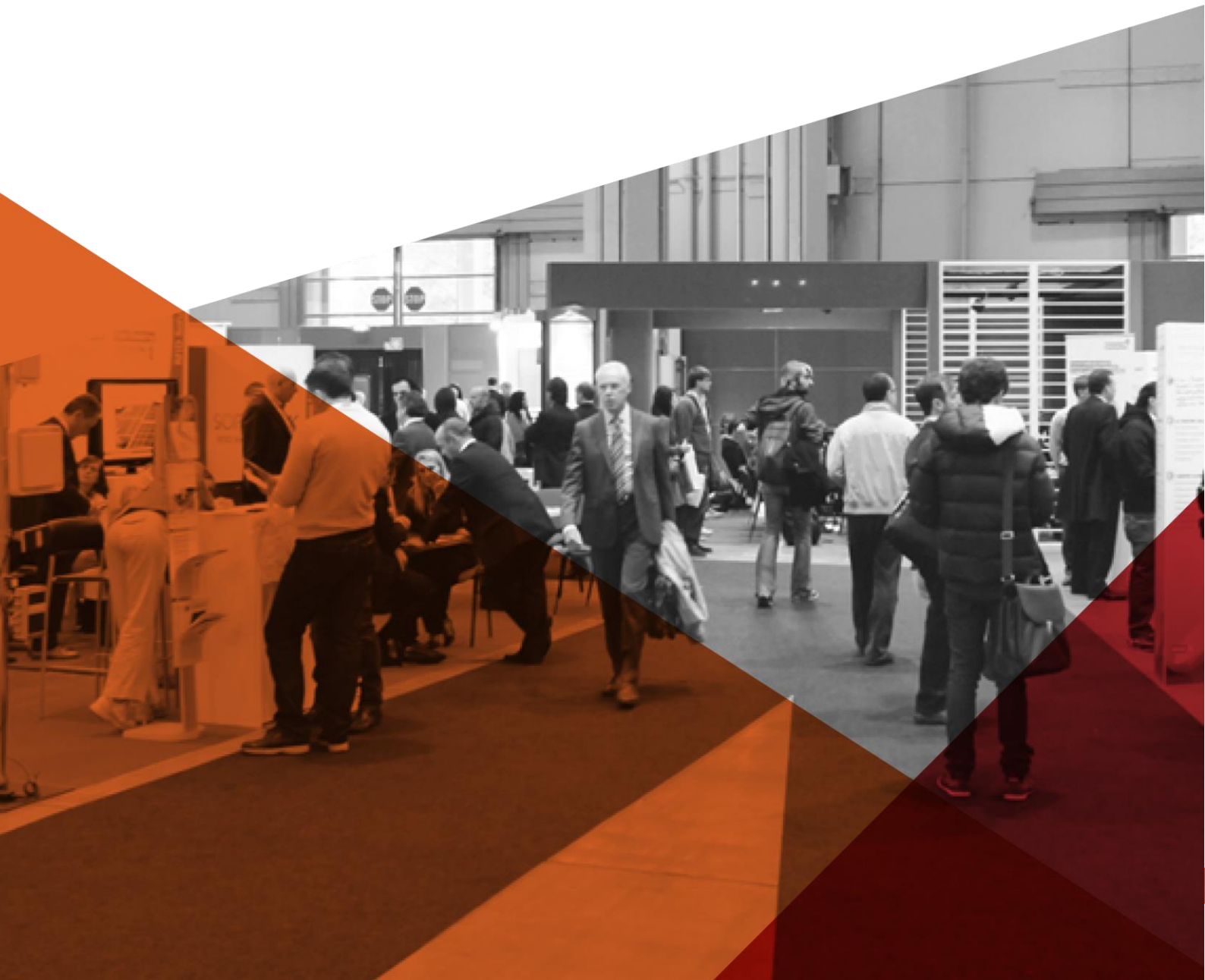

Arrival of Brochures by courier	7 Working days before show start
Copies of Bill of Lading and the Commercial Invoice and Packing List for sea freight consignments	3 Days before LCL cargo deadline 3 days before FCL cargo deadline
Arrival of exhibits shipped by sea freight	3 weeks before show start – LCL 2 weeks before show start – FCL
Copies of Commercial Invoice and Packing List for airfreight consignments	3 Days before cargo deadline

Deadline for Dispatch of Documents (Pre-Alerts)

To ensure no delays or undue inconvenience for customs clearance on arrival, it is imperative that copy of the vessel/flight details with master air waybill / ocean bill of lading detail be forwarded well in advance before the arrival of shipments according to the stipulated deadlines above.

Agility will not be responsible for any delays and any port/airport storage charges will be re-charged at cost. **For late submission of documents, a penalty fee will be charge at cost – as per receipt.**

IMPORTANT

Refer to the regulation from Finance Ministry of Indonesia No 158/PMK.04/2017 and the Directorate of Custom and Excise No. Per-38/BC/2017 which requires EDI Manifest to be submitted to Indonesian Custom latest 24 hours prior flight/vessel's departure or arrival date which has to real importer/consignee.

The Advanced Manifest must be submitted to Indonesian Custom Authority 24 hours prior to arrival port (for inbound shipment). Late and incorrect data manifest will lead to progressive Custom Penalty ranging from Idr 10,000,000.00–Idr 100,000,000.00/shipment.

In Addition, there will be a Custom Penalty for incorrect declaration of quantity and weight (Actual VS AWB), penalty ranging from Idr 25,000,000.00 – Idr 500,000,000.00/shipment.

a. DOCUMENT REQUIRED

1. SEAFREIGHT

- 3 original copies of Form Pam (commercial invoice) & certified packing list
- 3 original surrendered of Bill of Lading
- 1 Marine Insurance policy (if insured)
- Certificate of Fumigation
- Standard Packing ISPM#15
- Packing Declaration

All sea freight consignments must arrive at **Tanjung Priok Jakarta Seaport**

2. AIRFREIGHT

- 3 original copies of Form Pam (commercial invoice)
 - 2 copies to be attached to Airway Bill
 - 1 copy to be emailed to PT Agility F&E
- 3 original copies of Certified Packing List
 - 2 copies to be attached to Airway Bill
 - 1 copy to be emailed to PT Agility F&E
- Certificate of Fumigation.
- Standard packing ISPM#15
- Packing Declaration.

All Air freight consignments must arrive at **Jakarta/ Soekarno Hatta Airport**

3. ATA CARNET Is not required for show in Bonded Area

For the show in Bonded area ATA CARNET is not required , as cargo will consign to the venue & will automatically under temporary import .

b. HEAVYLIFT SURCHARGE

Individual exhibit in excess of 5,000 kg per package will incur heavy-lift surcharge (in addition to the basic handling charge).

These additional heavy-lift (Forklift, Crane, Special trucking etc) surcharges are applicable severally for inward movements as well as for outward movements.

c. HEAVY EXHIBITS (Containerize)

For the exhibitors which have heavy exhibits :

For INWARD :

- Please note that If bonded ware house is full , container will ground On the exhibition area as temporary storage and charges TBA. Demurrage & detention will bill as per receipt.
- Please get free detention & demurrage at least 21 days
- Additional trucking charges for empty container will be applied

For OUTWARD :

- Please note that If bonded ware house is full , cargo will keep at container as temporary storage
Container rental fee to be quoted upon request (option)
- If the exhibitors agreed to keep the exhibits outside at bonded ware house
With canvas coverage , we are not responsible if any damage & rusty
exhibitors agreed to keep the exhibits outside at
- For Heavy & sensitive machines , we would suggest vacuum packing to avoid / minimize any damages.

d. CD (Compact Disc) & USB

Do not send CD (compact disc) & USB by courier.
CD can send together via air or sea freight shipment (for total maximum can be send , it will be subject to custom approval)

e. FOOD & BEVERAGES

Importation for food & Beverage item subject to customs approval .
Cargo can to be imported via air freight shipment only with weight max.100kgs per exhibitor. Special storage and arrangement fee for closing document to be quoted upon request.

f. MEDICAL EQUIPMENT

Special permit will be required for those item which is requires special permit depending on HS code .

g. RETURN ISNTRUCTION

It is imperative that all exhibitor complete and sign the Return Shipping Instruction. Exhibitor should either visit our site office or Agility representative go to you booth stand to complete the disposal instruction .

During the show Agility not accept responsibility for ant damage or any loss .

h. SOLD GOODS

Transfer document from temporary import to permanent import for items with no special license required.

All goods must be transferred into the custom bonded warehouse , pending the completion of duty payment formalities.

Duty payment formalities would usually take 3 to 4 weeks to be finalized .

CUSTOMS REGULATIONS

SALE OF EXHIBITS

Goods may be sold during the exhibition but under no circumstances can they be removed from the Fairgrounds until duties/taxes have been paid and permanent customs import procedures have been completed.

Meanwhile, these goods are required to be removed to a bonded warehouse until the necessary documentation is completed. The minimum period needed to process permanent customs import document is 3 weeks. Exhibitors are allowed to store their goods in their facility for up to 1 month from the close of the exhibition, after which duty must be paid or the goods to be re-exported

NOTE:

All computation of duties/taxes will be based on the HS Code indicated on FORM Pam. The Customs Authorities are empowered to amend the HS Code and uplift the declared CIF value based on the new/uplifted value.

The Indonesian Customs Amendment Rights is valid for ten (10) years from date of import and exhibitors or buyers shall be responsible for all miss declarations. In such cases, heavy penalty and the balance of duty/taxes must be paid accordingly.

INSURANCE

We would like to advise that it is the responsibility of each exhibitor to arrange Marine (Transport) Insurance covering transport to the exhibition, during the exhibition, and the return of the exhibits to domicile, including the period the exhibits are handled by PT Agility (Fairs & Events), and also ensure that Transport Insurance in arranged for exhibits sold locally.

Upon written instructions, PT Agility (Fairs & Events) can offer the exhibitor insurance coverage at competitive premiums.
