1. INBOUND HANDLING TARIFF

1.1 SEA FREIGHT FCL

From free arrival at Riyadh dry port till delivery to the exhibition stand (one time positioning) inclusive of removal and temporary storage of empties on site, subject to free storage availability at the venue.

1.2 SEA FREIGHT LCL

From free arrival at Riyadh dry port till delivery to the exhibition stand (one time positioning) inclusive of removal and temporary storage of empties on site, subject to free storage availability at the venue.

Inbound handling charge		USD 150.00 per cbm or 1,000 kgs whichever is higher
Minimum handling charge		USD 1,000.00 per shipment per BL
Customs examination fee		USD 150.00 per shipment per container
Shipping line, Port charges		As per actual receipt + 15% outlay fee
Consignment service fee		1.5% of CIF value, minimum USD 200.00 per invoice per exhibitor

REMARKS:

- We do not recommend use of LCL service
- Irrespective of the arrival deadline, storage charges would be applicable after the free time.
- Temporary Importation of LCL is not possible and all cargo will be cleared by paying customs duty on final basis.

1.3 AIR FREIGHT SHIPMENTS

From free arrival at Riyadh airport till delivery to the exhibition stand (one time positioning) inclusive of removal and temporary storage of empties on site, subject to free storage availability at the venue (not applicable for consolidated shipments with multiple exhibitors).

FOR GENERAL CARGO

Customs examination fee	USD 150.00 per shipment per exhibitor
Airline, Airport charges	As per actual receipt + 15% outlay fee

REMARKS:

- Airport storage charges are additional and will be applicable from the day of arrival.
- For hazardous cargo, charges will be quoted on a case to case basis.
- For Consolidated invoices, additional charge of USD 90.00 per exhibitor will be charged in addition to inbound handling.

1.4 COURIER SHIPMENT UP TO 20 KGS WITHOUT CLEARANCE

- Airfreight tariff will be applicable for any courier shipment that needs customs clearance subject to all documents being in order as per Saudi customs regulations.

1.5 ROAD FREIGHT INBOUND CHARGES

Customs clearance from free arrival at Saudi Border, offloading at exhibition centre(FOT Basis) and delivery to stand, inclusive removal and temporary storage of empties on site, subject to free storage availability at the venue.

- Customs duty will be applicable for all GCC imports and exports at each destination for road freight.

EXCLUSIONS FOR ABOVE INBOUND RATES

- Above service excludes unpacking, stand dressing, assembly of display panels, machinery or decoration of any kind for Inbound. In case any special service is required, it will be subject to mutual agreement with the exhibitor and additional charges will be applicable.
- The above charges **exclude shipping line charges, shipping line agency charges, airport charges, airport agency handling charges, duty** etc. In case, any such charges are applicable, it will be billed as per receipt + 15% outlay fee.

- Container demurrage, port storage, trailer detention and any unforeseen charges if incurred will be charged accordingly at cost + 15% outlay fee.
- Any additional service charges incurred due to circumstance beyond our control and/or levied by the authorities, will be charged based on official receipt + 15% outlay fee.
- Multiple deliveries to different booths/halls will be charged additionally @USD 100.00 per exhibitor.

Includes return of empty cases to exhibition stand, loading onto truck, transport up to Riyadh airport (on FOT basis) and export customs clearance (not applicable for consolidated shipments with multiple exhibitors or 3rd party handovers).

2.4 ROAD FREIGHT CHARGES

Include return of empty cases to exhibition stand, loading onto of truck (FOT basis) and export customs clearance at Saudi Border.

3 ton truck, minimum 08 cbm	USD 85.00 per cbm or 1,000 kgs whichever is higher
7 ton truck, minimum 15 cbm	USD 85.00 per cbm or 1,000 kgs whichever is higher

- Customs duty will be applicable for all GCC Imports and Exports at each destination for road freight.

EXCLUSIONS FOR ALL ABOVE OUTBOUND RATES

- Above service excludes repacking, dismantling of display panels, machinery or decoration of any kind for Inbound. In case any special service is required, it will be subject to mutual agreement with the Exhibitor and additional charges will be applicable.
- If same inbound container is used for re-export then line demurrage will be applicable till the date the container is returned back to the port.
- For return shipments booked on freight collect basis, a co-ordination fee is applicable and should be agreed with us in advance preferably during the sales process.
- The above charges **exclude shipping line charges, seaport charges, airport charges, airport agency handling charges, return freight charges for Air/Sea/Road** and any type insurance.
- For re-export of road freight shipments to GCC, translation charges will be applicable at cost+15% service fee.
- Any additional service charges incurred due to circumstance beyond our control and/or levied by the authorities, will be charged based on official receipt + 15% outlay fee.

2.6 LATE ARRIVAL SURCHARGES

**Although above charges would be applicable, Agility will not be able to guarantee delivery before the opening of the exhibition or during the show.

2.7 SPECIAL RATE ON REQUEST

- Heavy-lift surcharge for over 2000 kg & less than 8000 kg per unit or for units in excess of 2(l) x 2(w) x 1.5(h) meters for sea air freight is charged at handling tariff plus 50%.
- These additional heavy-lift charges will apply for inward movements as well as for outward movements.
- Charges are for one time positioning only. Any additional re-positioning will incur extra charges.
- Exhibits exceeding 8,000 kg per package will be subject to an individual quotation when the dimensions and weights are provided.
- Handling of Dangerous / Perishable goods
- Forklift charges for assembling / dismantling if applicable.
- Re-packing and cost of any kind of packing materials.
- Prior request should be made for any additional requirement for labour, forklift, crane or any other equipment and obtain our confirmation.

NOTES:

- Above rates are based on the work carried out during working days i.e. from Sunday to Thursday 0800 to 1800 hrs.
- Any charges incurred due to circumstances beyond our control and or levied by any authority will be charged to your account.
- All shipments must be sent on prepaid basis.
- In case of re-export being handled by another agent, export documentation and handling charges will be applicable and would be advised on a case to case basis.
- Goods classed as restricted items by KSA Customs may incur penalties.
- Quite often KSA Customs authorities will delay the clearance of your shipment due to changes in documentation required for clearance or due to their misunderstanding of the materials you are sending. Should this happen it can take up to 3 weeks for them to process the shipment for clearance. This can be avoided by paying a 'fine' to the customs officer, this will be advised on a case by case basis and is **completely** out of our control. NO receipt can be provided in this instance

Unless all the conditions mentioned in these instructions are strictly complied with, we cannot be held responsible for late or non-delivery of cargo to the exhibition.
